ACTIVATION OF AUTODNS ACCOUNT FOR EXTERNAL API IMPLEMENTATION

InterNetX provides a centralized whois service to simplify whois queries, the WhoisProxy. The WhoisProxy effectively is an intermediary service and accesses the respective whois servers of the registry, thus eliminating the need to poll the various whois servers for different TLDs.

If you currently do not use a WhoisProxy, you can request the free "Standard" version of the InterNetX WhoisProxy below. Packages with larger query quotas can be booked at the according prices.
